Please remind your fellow officers that all they have to do is have a conversation with JDC staff. If they say I really want this kid held, 9 times out of 10 we can make it happen.

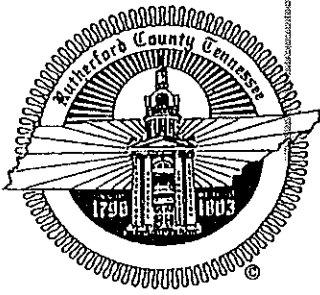

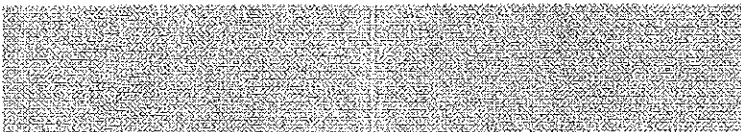
